President's Message Dr. Ron Dufalla, ACASR President

As I write this message, it is a beautiful sunny summer morning. It is one of those mornings when you can comfortably sit on the porch enjoying your coffee or tea before the high heat and humidity we have experienced this summer returns for the afternoon. Please allow me to use this message to inform you of important information from PASR and ACASR.

The 2025 PASR biennial meeting of the House of Delegates is scheduled for October 5-7, 2025, at the Penn Stater Hotel and Conference Center in State College, PA. "Staying Alive in 2025: Relax, Refresh, Renew" is the theme for this year's event. Any PASR member is encouraged to attend. With a bylaw change that was approved during the 2023 House of Delegates, ACASR is permitted to send seven voting delegates. At the 2023 House of Delegates, ACASR was only allotted one voting delegate. Unfortunately for our chapter, we only have three individuals that have volunteered to travel to State College for this important meeting. If any ACASR member would like to join the delegation of three, please let me know as soon as possible. At this conference, insights will be provided into how chapters can effectively and efficiently operate and meet the challenges they may currently face. In addition, voting delegates will be asked to cast ballots for the election of PASR officers including President, President-elect, Vice President, and Treasurer, as well as, any proposed changes to PASR bylaws. Look for a review of the 2025 House of Delegates in the next newsletter.

As mentioned in a previous newsletter, I accepted the position of Region 12 representative on PASR's Member Benefits and Services (MB&S) Committee. During a recent meeting of the committee, a partnership between PASR and Life Line Screening was approved. Guest Speaker for the Region 12 Fall Luncheon scheduled for Thursday, September 18 at Edgewood Country Club

The Guest Speaker will be Joe Guiffre, a Senior Justice Advocate for the Allegheny County District Attorney's Office Joe and his colleagues are known as the Allegheny County Fraud Squad. They work with Senior Citizens dealing with fraud, scams and abuse of Seniors. The Fraud Squad speaks to groups all over Allegheny County informing them of 1) what to watch for from scammers, 2) inform them of any scams and 3) how to report them to the Fraud Squad. Joe will be picking up where Cyndie left off in the Spring luncheon with Scams part 2. You will receive information about what is being done behind the scenes to support older adults who have come through the system as well as what we ALL can do to prevent further abuses to our aging population. You will hear about the latest scams and how to avoid them. Questions and comments will be encouraged.

Educational Support

In June of 2024 our Ed Support team awarded our \$750 Educational Grant to Colleen Tortorella, a guidance counselor at Gateway High School. Colleen applied for the grant to help purchase supplies for her Grief support group. Collen came to our July board meeting to personally thank us and to tell us how the money was spent. Wow. We were impressed. Colleen works with the Highmark Caring Place which gives information and suggestions to individual Care Teams and groups as well as many other services. The Thursday before Thanksgiving is Children's Grief Awareness Day. Colleen and her students work from September through November to raise money by selling cookies, manning a food booth at Homecoming, selling butterfly tattoos, running a carnival in October, making blue ribbons and other projects. Our grant money enabled Colleen to purchase blue t-shirts for her team and supplies and snacks for meetings. There is a white tree in the school that students can put a blue ornament on in memory of a loved one. All money raised goes back into the club. She said the kids like to be part of something meaningful. Colleen showed a seven-minute video of the year's work. We all felt it was money well spent.



The 2025 Educational Scholarship is awarded to Ella Bienier, a graduate of Deer Lakes High School. Ella is planning to enroll at Slippery Rock University as a dual major, Pre K-4 Early this fall Education and Special Education. An honor student for her entire high school career, she maintained a rigorous academic schedule at Deer Lakes and A.W. Beattie Career and Technical She also received scores worthy of college credit for the A.P. exams she tested. She has received commendation from the PA House of Representatives, and was a member of the National Honor Society and the National Technical Honor Society. Ella lettered in track (2 years) and cross country (4 years) during high school while also maintaining a part time job at a local coffee shop. She has participated in a variety of volunteer programs, especially Best Buddies. Upon successful completion of her first semester at Slippery Rock, Ella will receive a check from ACASR to use as she needs for her education.

The Region 12 Spring General Membership Meeting and Luncheon was held at the LeMont Restaurant on Thursday, May 1st. There were about 50 attendees and it was hosted by the Pittsburgh Chapter.



The membership meeting was called to order by Glory Getty, President of the Pittsburgh Chapter. Bob Marko, Region 12 Director, then extended his greetings and gave an update from PASR's Legislative/Political Education Committee, focusing mainly on the progression of the 2025 COLA bill. In the absence of President Ron Dufalla, Donna Dado, Secretary of the Allegheny Chapter gave the chapter update. Donna also provided postcards and addresses for contacting legislators, asking for their support of the COLA bill.

A PASR Commendation for Joe Poerio's work with both Region 12 and the Pittsburgh Chapter was presented to his widow Paula and his son Brian, by Pittsburgh's Community Service Committee. Joe was a member of the committee, as well as, James White and Denyse Littles Cullens. James and Denyse also introduced Pittsburgh Chapter's new Community Service Partner, H.O.P.E. for Tomorrow and its founder Keysha Gomez. Keysha spoke briefly to the meeting about the work that her organization does in the West End of Pittsburgh. A 50/50 fundraising raffle was held during the meeting/luncheon with the proceeds going to H.O.P.E. for Tomorrow.





After lunch, guest speaker Cyndie Carioli, Senior Justice Advocate from the Allegheny County District Attorney's Office, spoke on "Red Flags, Learn How to Avoid Becoming a Victim of Scamming and Fraud." Cyndie provided some very helpful information through her speech and through the handouts she made available. She also made plenty of time to answer attendee's questions. Her presentation was very much appreciated.

Legislative/COLA

If you have not visited our parent organization, PASR, in the last few months, here is what was posted on their website prior to passing the state budget. As you can see, they are working right down to the wire. However, it takes ALL of us to contact our legislators and show Harrisburg there are many of us who need this COLA and also vote in elections.

Update 7/14/25:

We are encouraged that Governor Shapiro has prioritized seniors in several areas, such as prescription affordability and property tax rebates. Still, retirees like ours have not yet received full support for a COLA. That must change.

The House has already acted by passing HB 411 with bipartisan support. Senator Farry's SB 721 offers a fiscally responsible solution, indexing modest COLAs to Pre-Act 9 retirees. These proposals represent less than 0.002% of the state budget — a minimal cost for a major impact.

The state budget is still being finalized, and this could be our last, best chance to push for a meaningful cost-of-living adjustment (COLA).

Every voice could make the difference in ensuring our legislators understand just how essential COLA is for our retirees. We're asking everyone to join us in reaching out right now.

The more they hear from us, the stronger our message becomes.
